The 117 Public Safety Answering Points (PSAPs) in Indiana are comprised up of 91 Primary PSAPs, 20 Secondary PSAPs, and 6 Indiana State Police post PSAPs.


2022 Funding and Expenditures Report

All but two secondary PSAPs (New Albany City Dispatch and Rushville PD) filed a 2022 Funding and Expenditures Report with the Statewide 911 Board. The Funding and Expenditure Report is a detailed document completed by the Auditor and/or the PSAP Director detailing the PSAP's annual expenses and funding sources for the year.

PSAPs reported a total of \$212,350,449.16 in expenditures for 2022.



PSAP REPORTED EXPENDITURES BY AGENCY TYPE





In 2022, the total cost for 911 in Indiana was \$230,675,002.37.

This total includes 1222 funds spent as reported by the 115 PSAPs that filed a 2022 Funding and Expenditures Report along with the network operating expenses and training program funds provided by the Statewide 911 Board. The network operating expenses include the wireless network, MEVO, Text for 911 services and Language Line.

2022 Call Counts


The following Call Count numbers were taken from the Statewide 911 Board's analytics; ECaTS (Emergency Call Tracking System) for calls, and INdigital Toolkit for text sessions.

In 2022, **3,511,746** 911 calls were tracked.

- 3,073,184- Wireless
 - Includes 245,215-NSI (Non-Service Initialized)
- 193,675-Wireline
- 244,887-VOIP

Number of PSAP Personnel


In 2022, the 116 PSAPs who completed the 2022 PSAP Fact Sheet reported having 2,289 staff members. This includes Directors, Supervisors, CTO's, Telecommunicators, etc.

There were 1,826 full-time Telecommunicators and 290 part-time Telecommunicators reported.



PSAPs reported that in 2022, they had a total of 715 consoles, with a minimum of 372 of them manned daily.





Training Program

In December 2017, the Statewide 911 Board approved the recommended minimum training guidelines for telecommunicators. These guidelines identified nationally recognized, universally accepted, minimum topics that can be used to train aspiring and current 911 telecommunicators.

The Board then earmarked funds to provide <u>certified basic training</u> and recertifications for Indiana telecommunicators beginning in January 2018.

Through the Board's funding, Indiana PSAPs saved more than \$567,950 in training costs in 2022.



TRAINING PARTICIPANTS BY COUNTY


In 2022, another two PSAPs utilized funding from the Board for their training programs, bringing the total to 113 agencies from 86 counties who have participated since it began.


